1. Name of the Society : JYOTI MEDICAL & WELFARE SOCIETY
2. Registered Office : The registered office of the Society shall be situated within the Union Territory of Delhi and at present, it is following Address: E-269, Gandhi Vihar, Delhi-110009.

3. AIMS AND OBJECTIVES

Main objects for which the Society is formed are as under :-

- 1) To establish service, educational and research communities in order to further the cause of neo-humanistic living establishing the love for Plants, Animals, Humans and even inanimate world.
- 2) To establish necessary educational institutions in the fields of humanities, arts and sciences, both of vocational and non-vocational nature, and for all ages.
- 3) To provide common forums for staff, students and residents of the educational institutions in order to conduct welfare activities for the students, particularly scheduled classes and tribals.
- 4) To undertake research in any field of human interest and establish training programmes to disseminate knowledge for the all-round development of the people.
- 5) To promote, establish, manage and maintain institutions for imparting education to the students.
- 6) To establish institutions and organise programmes to help women become self-reliant in economic affairs.
- 7) To publish books, journals, etc. for nurturing neo-humanistic values in all branches of human knowledge. The income of the publications will be utilised for the development of institutions of learning and culture.
- 8) To collect, co-ordinate and disseminate medical, scientific or other knowledge, data, statistics and information as to the causation, prevalence, distribution, treatment or cure of all type of disease or any other data, statistics or information as may seem expedient and to establish a bureau or bureaux for the collection and dissemination of such knowledge, data and information, as aforesaid.
- 9) To study and undertake scientific research on all aspects of all type of disease and to investigate its incidence, prevalence, distribution, causes, symptoms, and to promote its cure.






- 10) To establish, maintain and run/Treatment/Research Institutes, Infirmaries, Terminal Cancer Patients Homes, Cancer Detection Centres, Rehabilitation Centres for undertaking and pursuing Combined efforts to fight the disease of Cancer.
 - 11) To Provide Medical relief to the deserving and backward classes.
 - 12) To construct and establish, clinics and hospitals in the National Capital Territory of Delhi for providing such medical relief and afford facilities.
 - 13) Establishment of research centres for complicating diseases, set up laboratories, testing equipment, and engage specialists for such ailments.
 - 14) To open Establish/Run/Maintain Dharmshala, Guest House, Community Hall, for poor and needy persons at large and to improve living conditions in respect of security, cleanliness, maintenance of parks, sanctuaries, roads, water supply, sewage, drainage, entegy centres, transportation facilities and amenities that may be required from time to time.
 - 15) Grant of medical relief in any form to destitute orphans and to needy and poor persons who are maimed, blind, infirm and handicapped to the similar other persons.
 - 16) To provide requisite facilities for fundamental and clinical research in relation to all type diseases and dissemination of the results of research so undertaken.
 - 17) Establishing, maintaining or contributing towards construction of buildings required for purposes in conformity and connected with the development of Hospital and for Medical activities of the Society.
 - 18) To educate, train and secure medical, nursing and other volunteers and personnel for removal of all type of disease and to afford facilities for such training in India or abroad.
 - 19) To assist, by providing work of opportunities for being engaged in activities for the rehabilitation of discharged patients.
 - 20) To established necessary educational institutions in the fields of humanities, arts and sciences, both of vocational and non-vocational nature, and for all ages.
 - 21) To Promote, establish, manage educational institutions for imparting education to the general public.
 - 22) To create awareness and give training to the poor and downtrodden children and the young people, in some craft which ensures them reasonable livelihood.
 - 23) To arrange marriage of poor and needy women and to give financial subsidies and grants, grants-in-aid, education to their children and medical treatment when necessary.

24. To receive and disseminate contributions either in cash or in kind from any person, firm, company, institution, or other source for such purposes and objects as are enumerated in this charter.

26. To do all such other acts which may be necessary for the proper conduct of the aims and objects of the Society.


27. This association shall be purely a non-political and non-party body.

28. All the income, earnings, movable, immovable properties of the Society shall be strictly utilized and applied towards the promotion of education and the general welfare of the poor, widows, orphans and the women who have to be taken care of the poor members of the Society or to assist any person deserving through and out of work or the parents or the poor members of the Society or to any other person deserving. No member of the Society shall have any personal claim on the income or movable properties of the Society or have any private share or interest in the assets of the membership.

**RULES AND REGULATIONS
JYOTI MEDICAL & WELFARE SOCIETY**

1. MEMBERSHIP

The membership of the Society is open to any person or persons who has attained the age of maturity and fulfils the terms and conditions of the Society, without discrimination of religion, caste, colour or creed, but subject to the approval of the governing body. If the membership is refused to a certain person or persons the reason for refusal shall be communicated to the individual member concerned.


2. SUBSCRIPTION

Admission fee Rs. 10,000/- at the time of admission.
Subscription Rs. 1,000/- yearly.

3. TERMINATION OF MEMBERSHIP


The governing body shall have the power to expel a member from the Society on the following terms and conditions :-

- a) By no confidence motion passed by 2/3rd majority of members voting in the general body meeting.
 - b) On his/her death.
 - c) Non-payment of subscription and of financial year from due date.
 - d) On his/her written resignation.
 - e) On his/her not attending three consecutive meetings of the general body without intension.
- The reason of termination of membership shall be communicated to the member concerned.



4. APPEALS

All the appeals should be referred to the general body of the Society and the decision of the general body shall be final. The reason for rejection shall be communicated to the member concerned.



5. RE-ADMISSION

In the case of a member expelled by the general body the same can be re-admitted provided the member concerned pays all the dues upto date. However, the decision of the general body shall be final. This clause is applicable to clause 3 para 'C' only.

6. GOVERNING BODY



7. BANK ACCOUNT

The Bank Account of the Society shall be operated by the President and/or Secretary and/or treasurer as mutually agreed from time to time.

8. GENERAL BODY

All the members of the Society will constitute the general body.

9. FUNCTIONS OF THE GENERAL BODY

- a) To consider any business brought forward by the governing body.
- b) There shall be an annual meeting of the General body in the month of March every year.
- c) Not less than 15 days notice shall be given to the members before the date of general body meeting enclosing the agenda specifying date, time, place. The quorum shall be 1/3rd.

10. SOURCES OF INCOME

- a) Admission fee
- b) Subscriptions.
- c) Donations and special contributions.

The income of the Society received from all sources shall be utilised only for the promotion of its aims and objects.


11. GOVERNING BODY

The governing body shall be not less than 7 and not more than 21. The members of the governing body shall hold office for five years. The meetings of the governing body shall be held as and when necessary for which 15 days clear notice will be required. The quorum shall be 2/3rd.



12. ELECTION AND QUORUM

The General body in its meeting will elect its president and all the office bearers and members after five years by secret ballot. The quorum of the general body shall be 2/3rd. A list of the newly elected governing body will be submitted with the Registrar of Societies by three outgoing Governing body members.



13. FUNCTIONS OF THE GOVERNING BODY

- a) To arrange finance if required from Bank(s), institutions or individuals on reasonable terms and conditions and the governing body as a whole will be liable for its return.
- b) To make plans for the future programmes of the Society.
- c) To appoint, terminate and duties of any staff.
- d) To accept donations, charities, loans, grants properties, etc. from public, other associations, agencies, Govt. Deptts. in the interest of the promotion of the aims and objects of the Society.
- e) The governing body shall meet at least once in a month.

14. MANAGEMENT OF FUNDS

- a) The name and address of the member.
- b) The date on which the member was admitted.
- c) The date on which a member ceased to be such member.


16. RIGHTS AND PRIVILEGES OF THE MEMBERS

All and every member of the Society :

- a) Shall have one vote at every meeting.
- b) Shall be entitled to participate in the meeting and religious functions and gatherings of the Society.
- c) Shall have the right to inspect the books of accounts of the Society on any working day during business hours by giving reasonable notice.
- d) Shall be bound by the Rules and Regulations and/or by-laws which may be framed from time to time.
- e) To elect the governing body of the Society.
- f) To attend the general meeting as and when required.
- g) To inform the Society pertaining to any matter of the Society.

17. FILLING UP CASUAL VACANCIES

The casual vacancies may be filled up by the resolution passed by majority of vote by the governing body till next election is held.



18. POWERS AND DUTIES OF THE OFFICERS

PRESIDENT

- a) He/She will be the Head of the Society and preside over the meetings of the general body as well as of the Governing body. He/She will have the right of casting vote in case of a tie.
- b) The Vice president will exercise his powers and perform duties after the authority from the president.



SECRETARY

- a) To sign on behalf of the Society and to conduct its correspondence. To represent the Society in Court of Law.
- b) To summon meetings of the Society and record their proceedings.
